Gender-Based violence refers to harmful acts directed at an individual based on their gender. It is rooted in gender inequality, the abuse of power and harmful norms.

Domestic violence	Behaviour by an intimate partner or ex-partner that causes physical, sexual or psychological harm, including physical aggression, sexual coercion, psychological abuse and controlling behaviours.
Sexual violence	Physical, sexual, emotional, economic or psychological abuse within the household. Whereas intimate partner violence occurs between those in an intimate relationship, domestic violence victims can include anyone living within the same household, including children.



Intimate partner violence	Any sexual act, attempt to obtain a sexual act, or other act directed against a person's sexuality using coercion, by any person regardless of their relationship to the victim, in any setting. This includes rape.
